RENTAL TERMS AND CONDITIONS:

1. The renter shall keep and maintain the rented equipment during the terms of the rental at his own cost and expense. He/She shall keep the equipment in a good state of repair, normal wear and tear excepted.
2. The renter shall pay the owner full compensation for replacement and/or repair of any equipment which is not returned because it is lost or stolen or any equipment which is damaged. The owner's invoice for replacement or repair is conclusive as to the amount renter shall pay under this paragraph for repair or replacement.
3. The renter shall not remove the equipment from the address of the location shown herein as the place of use of equipment without the prior written approval of the owner. The renter shall inform the owner upon demand of the exact location of the equipment while it is in the renter's possession.
4. The renter will be responsible for paying half of their rental price if not ready for pick by the NEXT morning from the rental date. The renter will pay another full day of rental worth if given a day after the agreed pick-up date.
5. The renter is fully aware and takes full responsibility that failure to submit payment for any damages will result in legal action.
6. The renter understands the showing of an IDENTIFICATION to confirm the renter's name and address.
7. The renter acknowledges that the owner will not be responsible for any physical and/or mental damage caused by the equipment from improper use.
8. Bounce Houses: The renter is responsible for the safety of all children in the bounce house. We are not responsible for any physical and/or mental damage caused by the equipment. I have read and understood this clause. Initials: _____
9. Maximum of 8 children are allowed, no shoes, no food allowed in the bounce house.
10. The bouncy house must be delivered/returned clean.
11. The required deposit is not refunded if you CANCEL your event, or DAMAGE any equipment (chairs, tables, tents, heaters, lights, covers, etc), or do not leave your equipment folded and cleaned as it was when dropped off.
12. Oseguera's Party Rentals is not responsible for the set up of chairs and tables, unless otherwise discussed for an additional charge.
13. We are not responsible for cleaning after any event when we pick up the equipment. If we need to, all decorations/balloons will be thrown out that are attached or on any equipment.
14. The required deposit is not refunded if you do not leave the equipment as it was left this includes (folded chairs, folded tables and all equipment without trash).
15. Remove decorations or objects that are not part of our equipment.
